Retainer s Required	Retainers are based on the scope and complexity of work to be performed and generally are a minimum of \$3000.00 per case. Retainers for cases requiring an animation will be determined based on the scope and complexity of the case. At least half of the retainer will be held and applied to the final invoice. Once a retainer is exhausted, it will need to be replenished before any further work will be completed.
